I have received your request regarding the verification of the (6) PG&E meter addresses assigned to the property located at the Fountains Business Park. I understand the request is needed to establish the use of the assigned addresses with PG&E.

Our records indicate the business park (formerly known as the Lincoln-Durham Business Park) was originally addressed on September 14, 1984 to reflect the Lawrence Place and Randall Place addresses. No utility meter addresses were assigned at that time.
