RESOLUTION NO. 2019-34

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FREMONT CHANGING THE NAME OF LOPES COURT TO LOPES ROAD

WHEREAS, the City of Fremont desires to change the suffix of Lopes Court to Lopes Road to be in accordance with City naming conventions for north/south through street names; and

WHEREAS, a portion of Lopes Court traverses the Warm Springs/South Fremont Community Plan Area off South Gimmer Boulevard and the entire road is designated on the City General Plan as an Urban Street, measures approximately 2,235 feet long, and serves eight (8) existing addresses; and

WHEREAS, the Geographic Information Systems Division in accordance with the Community Development and Fire Departments is responsible for naming new streets and assigning street numbers within the city and has no objections to the renaming of Lopes Court to Lopes Road; and

WHEREAS, Lennar Homes of California, Inc. will pay for all labor and material costs attributed to this project for new street signs and poles in accordance with their development agreement; and,

WHEREAS, renaming Lopes Court to Lopes Road does not change the base name of the street and is consistent with and furthers the General Plan goal to maintain a connection between the community and everyday life.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF FREMONT
RESOLVES AS FOLLOWS:

1. The renaming of Lopes Court to Lopes Road is exempt from the requirements of the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15301, existing facilities, as it involves no expansion or change to the use of the street.
2. The request to change the name of Lopes Court to Lopes Road is approved and staff is directed to reflect this change on all relevant maps and resource documents maintained by the City.

3. The City Clerk is directed to forward a copy of this resolution to the Alameda County Board of Supervisors and all appropriate public agencies, utilities and other service providers to inform them of the name change.




