And, as part of this addressing action, fourteen (14) previously assigned addresses have been rescinded since they are no longer needed. 

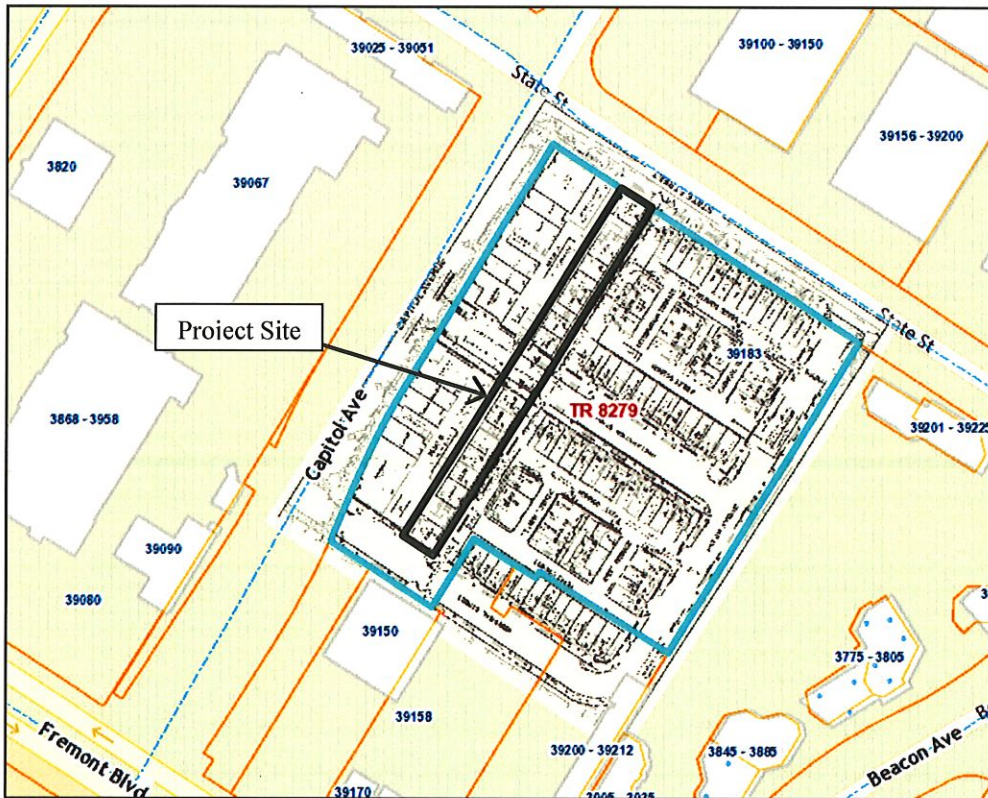
