Re: Verification of existing addresses for two industrial tenant spaces

- 3347 Gateway Blvd
- 3353 Gateway Blvd

To Whom It May Concern:

This letter is in response to your request regarding the validity of two addresses located at Assessor Parcel Number 519 169303601. I understand the request is needed to establish the use of the assigned addresses with PG&E. The addresses you wish to use are 3347 Gateway Blvd and 3353 Gateway Blvd.

Our records indicate that the addresses were issued to this site on September 1988 as part of the addresses for the original development. They are tenant space addresses and may be used in the location indicated. See Table "A" for an inventory of the active addresses for the building and the enclosed Addressing Plan for their location. A copy of this letter will also be forwarded to PG&E for their information.

The confusion over your addresses (i.e., 3347 Gateway Blvd and 3353 Gateway Blvd) might have occurred because the two tenant spaces had originally shared a common meter. Under the current tenant improvement work (BLD2012-02714), each tenant space will be serviced by its own utility meter. The addresses and their meters are as follows:

- **3347 Gateway Blvd:** The tenant space at this address will be assigned the existing meter (*formerly an 800A service which is being replaced by a 400A service*).
- **3353 Gateway Blvd:** The tenant space at this address will receive a new meter (*a 400A service*).

You will need to check your address records and posted address to make sure they match the assigned addresses (i.e., 3347 Gateway Blvd and 3353 Gateway Blvd). If they differ, they should be updated as soon as possible for the purpose of rapid identification of your property in the event of an emergency. In addition, please review and update any records that are registered with the City (such as for building permit and/or business tax purposes). By copy of this letter, we are notifying the below-listed agencies

and utility companies as well as PG&E. However, be aware that some agencies may not update their records until notified by the property owner. Therefore, it is your responsibility to make sure that the appropriate agencies or businesses acknowledge the correct address.
