In response to your request for an address needed for a new tenant space located at Assessor Parcel Number 519 101005002, one (1) address has been assigned. Our records indicate that there were three (3) addresses issued to the parcel (i.e. 48755, 48761 and 48767 Kato Road) at the time of initial construction in 1984. The present address of 48761 Kato Road is the property and building address. With this addressing action, the address of 48767 Kato Road is being reactivated and assigned for the new tenant space. In accordance with Title 15 (Buildings and Construction) Chapter 15.55 (House Numbering) of the Fremont Municipal Code, this letter serves as the notice of the addressing action affecting your property.
