This letter is in response to your request regarding the validity of one (1) address located at Assessor Parcel Number 513 073505900. I understand the request is needed to establish the use of the assigned address with the U.S. Post Office. The address you wish to use is 45162 Rutherford Ter.

Our records indicate the parcel address was assigned at the time of development to residential subdivision Tract 5632 on November 12, 1988. The address, 45162 Rutherford Ter, is a valid address assigned to Lot 63 of Tract 5632, and may be used at the location indicated. For a Full inventory and description of the address, please refer to Table "A" for a list of authorized addresses. The enclosed Addressing Plan illustrates the proper use and placement of the address.


